Objectives

The investment objective of this Product is to provide long-term capital growth. The Product aims to reflect, in a flexible manner, the Management Company's macro and micro vision of the markets.

BENCHMARK INDEX

The Product is actively managed through discretionary investments. The Product is not constrained by a benchmark.

In order to achieve this objective, the Product pursues a fund of fund investment strategy and will invest at least 50% of its net assets through investments in UCITS and/or UCIs (including but not limited to open-ended Exchange Traded Funds (ETFs) in all eligible types of assets classes, such as equities, bonds and money market instruments.

The allocation of the portfolio may vary according to the investment manager's expectations.

In accordance with the Investment Policy, up to 100% of the net assets of the Product may be exposed to in equity securities of issuers domiciled in the OECD countries. For the avoidance of doubt, regarding the possibility of the Product investing in countries domiciled outside the OECD, please see Schedule I.

The Product will invest in small, mid and large caps and may invest up to 20% of its net assets in small caps.

For the purpose of the investment policy of the Product, equity securities are, among others, direct investments in equities, other equity shares, dividend-right certificates, equity rights

and indirect investments through UCITS and/or UCIs.
In accordance with the Investment Policy, up to 100% of the net assets of the Product may be invested in money market instruments, term deposits maturing within one year at credit institutions, debt securities such as but not limited to treasury bills, and government and/or corporate fixed and/or floating rate bonds of all maturities of EU or OECD countries subject to prudential supervision.

The Product may invest up to 45% of its net assets in fixed income securities of issuers domiciled out of the OECD countries. There are no restrictions in terms of duration or rating of

For the avoidance of doubt, please note that the limit for non-investment grade bonds is forty percent (40%) of fixed income investments, for distressed debt the limit is five percent (5%) of the total fixed income investments and for unrated assets this is zero percent (0%).

For the purpose of the investment policy of the Product, the exposure to debt securities and money market instruments can be direct or indirect investments through UCITS and/or UCIs.

The Reference Currency of the Product is the EUR but the Product may invest in other OCDE currencies and up to 30% of the net assets may be denominated in non-OECD currencies.

The Product may use financial derivative instruments for hedging and investment purposes.

The investments underlying of this Product do not take into account the EU criteria for environmentally sustainable economic activities.

Non-distribution shares: any income generated by the Product is reinvested.

Please note that transaction costs may have material impact on performance.

Intended retail investor

The recommended time horizon for investors will be of the order of 3-5 or so years. This share is intended for all types of investors.

The type of investor for whom the Product is intended may include retail investors with no financial industry experience.



The summary risk indicator assumes you keep the Product until maturity end of the recommended holding period (5 years).

The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this Product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

In addition, you will be exposed to the following risks (not captured in the synthetic risk indicator), namely:

Credit risk: The issuer of a bond or other debt security (including, but not limited to, governments and their agencies, state and provincial governmental entities, supranationals and companies) may default on their obligations by failing to make payments due, or repay principal and interest in a timely manner which will affect the value of the debt securities held by the portfolio.

What happens if Abante Asesores Gestion SGIIC, S.A.U. is unable to pay out?
